- 2. Revenue State

- 5. Cost Recovery under for the year. Reconciliation being done and District will receive 300K either by the end of this year or over the next few years.

- 4. Tuition Budget: Special Education funding high due to being a little restrictive. Overall, budget is healthy and under budget.
